State Use Council Chair

Message from the Chairman:

As 2024 draws to a close, Georgia's State Use Council continues to move forward in a rapidly changing economic and social environment. A growing economy and job market in Georgia were tempered by inflation and uncertainty about continued economic growth.

The Georgia State Use Program was created by the Georgia Legislature over three decades ago to provide employment opportunities for Georgia's citizens with disabilities, through Georgia Enterprises for Products and Services (GEPS). This is a program where everyone wins: Georgians with disabilities who gain employment, and their families; the State of Georgia agencies, who can purchase high-quality products and services at competitive prices; and the non-profit agencies that employ our citizens to provide products and services.

The State Use Council partners with the Georgia Department of Administrative Services (DOAS—the procurement agency for state purchasing), and with our Central Non-profit Agency (CNA), which is the Georgia Association of Training, Employment, and Supports (GATES) which the State Use Council designates to manage GEPS (the state entity which provides for the day-to-day operations of the State Use Program). By working together, all these organizations ensure that the State Use Program engages people with disabilities and helps them get paying jobs that provide our state government agency customers with essential goods and services. During Fiscal Year 2024, the Georgia State Use Program showed an impressive increase in total revenue.

The State Use Program is a team effort, and our objective is the increased employment of Georgians with disabilities. The non-profit Community Rehabilitation Providers (CRPs) provide the products and services at the heart of the program which provides vocational training and employment for Georgia's citizens with disabilities. The CRPs, as well as those products and services they provide, are certified by the State Use Council to be eligible for the program. Fifty to seventy-five percent or more of the workforce used by the CRPs in their service contracts and products are required to be citizens with disabilities.

For fiscal 2024, our total program revenue was \$7,384,096, a 46% increase from the previous year. Our product sales in fiscal 2024 increased by 53%, reflecting the GEPS staff's hard work and our partner CRPs and Services revenue increased by 34% compared to the previous fiscal year.

Most of the service contracts in the State Use Program involve custodial services for State of Georgia agencies. While COVID-19 infections are nowhere near where they were in recent years, there remains a need for comprehensive cleaning along with frequent disinfection of state facilities. Additionally, while there continues to be a custodial staff shortage for the rest of the industry, GEPS and our CRPs are still able to tap the labor market for a greater supply of willing labor since individuals with disabilities traditionally must overcome a higher employment barrier and are eager to step up and fill the demand for custodial services.

We had a 44% increase in net assets in fiscal 2024, totaling \$506,097. Our outlook remains positive for fiscal 2025, and we have already seen encouraging results for the first three months of the new fiscal year.

Overall, the State Use Program provided 68,971 hours of employment for Georgians with disabilities in fiscal 2024; this represents a 40% increase from the previous year. The number of people with disabilities employed through the program decreased by 15% to 86 individuals. So, while we are encouraged by the demand levels for services that GEPS was able to fulfill for the

State, we are still working through the labor shortage in the market. We are hopeful that both numbers will increase in fiscal 2025.

The State Use Program continues its efforts to expand opportunities for Georgians with disabilities. While Georgia's 3.2% unemployment rate is below the national average (3.9%), this program remains vital to Georgians with disabilities since they have even higher-than-average rates of unemployment within the State. In this annual report, you will see the "Faces of State Use" and the awards these individuals received as GEPS and the State Use Council celebrated the contributions of these individuals whose hard work continues to ensure the success of this program as it provides meaningful and rewarding employment for themselves as well as others across the state. The need for job opportunities for our citizens with disabilities continues to increase, and the State Use Program will continue to address that need.

The State Use Program continues to strive for growth and expand the program by finding new products and services to offer. This past September, we were able to re-certify hundreds of existing products for fiscal year 2025; and certify many more new products, including heavy-duty microfiber cloths, blue polyethylene food gloves, and over 45 new remanufactured toner cartridges. By providing new and improved product lines, GEPS expects to further increase employment opportunities within the State Use Program for Georgians with disabilities.

We all must continue to work together to ensure that this program continues to help more of those individuals who benefit so much from our efforts. The purpose of this program is as relevant today as it was in 1993 when it was created. Since this program is clearly in the best interest of the State of Georgia, the employers, and all served by it, I do not doubt that the State Use Program will continue to serve this vital purpose well into the future. Together, we will move the State Use Program forward as our efforts continue to improve the lives of so many of those individuals who might otherwise not be able to overcome the obstacles that they face.

My favorite TV show has a character named Christopher Pike, who said in the premiere episode, "Our ability to work together is our greatest strength." It's going to take all our partners—the DOAS, the CRPs, GATES, and most of all, the people who want to help Georgians with disabilities—to expand and improve this program, and if we all work together, we can make it happen.

On behalf of the Georgia State Use Council, I invite you to support our efforts to put Georgians with disabilities to work. As you review this report, you will see the "Faces of State Use" and the significant contributions this program is making to the lives of those involved in the State Use Program.

We look forward to the continued growth and success of the State Use Program as it serves Georgians with disabilities!

Columbus State University's commitment to continue purchasing those mandatory products from GEPS is the kind of cooperation that continues to provide even more employment opportunities for individuals with disabilities throughout the state of Georgia.





State Use Labor Hours of Disabled Employees FY 2023 & FY 2024 as of June 30, 2024





Comparative State Use - Disabled Workers Used FY 2023 & FY 2024 as of June 30, 2024



State Use Program labor hours of disabled employees totaled 68,971 hours in FY24. That is a 40% increase from the total number of hours disabled Georgians were employed in the program in FY23. During the same period, there was a 15% decrease in the number of workers employed by the program in 2024.

A Vision for Empowerment

The Georgia Legislature established the State Use Council in 1993 to offer quality services and products to be used by state and local government agencies. The statute requires state agencies and political subdivisions to purchase those products and services from Certified Rehabilitation Programs (CRPs) employing Georgians with disabilities. This, in turn, would improve the quality of life for Georgia's citizens with disabilities by providing employment opportunities from the production of those products and services.

The State Use Council designates a private nonprofit agency to administer daily operations on behalf of the Council. This program is Georgia Enterprises for Products and Services, and its nonprofit administering agency is the Georgia Association of Training, Employment, and Supports (GATES). The State Use Council ensures that services and products are priced at a fair market value and are of the highest quality. This is a unique partnership between the government and the private nonprofit sector. Georgia Enterprises for Products and Services operates on these guiding objectives:

- Dedication to encouraging and assisting individuals with disabilities to achieve maximum personal independence by engaging in useful and productive vocational activities.
- Working to facilitate and expand employment opportunities for people with disabilities through state and local programs.
- Striving to develop an environment for successful employment of people with disabilities through marketing research, public relations, and educational activities.
- Developing cooperative relationships with business, state, and local community leaders that promote programs that support the employment of Georgia's citizens with disabilities.
