Message from the Chairman:

The Georgia State Use Program was created by the Georgia Legislature in 1993 to provide employment opportunities for Georgia's citizens with disabilities. This was a brilliantly conceived program where everyone wins. The citizens with disabilities who gain employment, their families, the State of Georgia, and the non-profit agencies which employ these citizens to provide the products and services needed by State agencies. The purpose of this program is as relevant today as it was twenty-five years ago when it was created. Since this program is clearly in the best interest of the State of Georgia, the employers and all served by it, I have no doubt that the State Use Program will continue to serve this vital purpose well into the future.

The State Use Program is a team effort with each unit of the team's focus being citizens with disabilities. Each team member's participation is vitally important to success of the program. In addition to the State Use Council and Georgia Enterprises for Products and Services (GEPS), there are other units that are essential to the success of the program. The non-profit community resource providers (CRPs) provide the products and services at the heart off the program and employ the citizens with disabilities that drive the program. The CRPs, as well as their products and services, are certified by the State Use Council to be eligible to be part of the program. Seventy-five percent (75%) or more of the work force used by the CRPs in the products and service contracts are to be citizens with disabilities. The Georgia Department of Administrative Services makes it possible for certain products and services to be mandatory or preferred products for State agencies. These State agencies make up the market where these products and services are purchased. However, it is the citizens with disabilities themselves, who produce these quality products and services to the State, which are the driving force of the State Use program. The wonderful thing is that those individuals with disabilities are not only being provided the opportunity for employment, but their efforts help drive the program to create opportunity for others with disabilities. Together, as a team, we propel State Use forward as our efforts continue to improve the lives of so many of those individuals who might otherwise not be able to overcome the obstacles that they face.

The overall economic outlook continues to show steady improvement and the State Use Program continues its efforts to expand opportunities for Georgians with disabilities. And while Georgia's 3.4% unemployment rate is now slightly below the national average (3.6%), this program remains vital to Georgians with disabilities since they have even higher-than-average rates of unemployment within the State. These 'faces of state use' work hard to ensure the program provides meaningful and rewarding employment for those with disabilities. There continues to be a tremendous need in our state to provide job opportunities for our citizens with disabilities, and the State Use Program continually strives to address those needs.

The success of the State Use Program is accomplished through multiple partners which include the State Use Council, the Georgia Department of Administrative Services, and the Central Non-profit Agency which is aptly named Georgia Association of Training, Employment, and Supports (GATES). GATES encompasses GEPS which provides for the day-to-day operations of the State Use Program. By working collectively, these organizations assure that the State Use Program engages people with disabilities and helps them to provide our governmental agency customers with essential goods and services. During FY19, the Georgia State Use Program continued to have a strong financial and 'mission' focus. Our State Use Program staff members continue to work toward the growth and enhancement of the program utilizing the

updated State Use Operational Plan. This plan's four key strategies continue to be:

- 1. Enhancing the System and State Use Program Effectiveness
- 2. Building Capability and Capacity
- 3. Increasing Successful Product and Service Awards
- 4. Enhancing the Marketing of the Program

In FY19 product sales for GEPS increased 10% from the previous year ending up at \$2,614,644 and service contracts showed a decrease of 15% with a final revenue of \$1,062,883. With all sources of revenue combined, the program revenues came in at \$3,717,523 which is a 1% increase over FY18. By the end of the fiscal year, the program had a 15% increase in net assets from FY18 \$162,397 to FY19 \$186,912. The outlook continues to remain positive due to the continued efforts to increase product sales, the addition of new products to the program, winning new service contracts, and the grant that GEPS has received for FY20 from the Georgia Vocational Rehabilitation Agency.

In FY19, through the products sold to the State and the State service contracts, the State Use Program provided 58,362 hours of employment for Georgians with disabilities. This was a 4% decrease from the 60,874 hours of employment in FY18 and the number of people with disabilities employed through the program also decreased in FY19 to 122 which is 14% lower than FY18 (142). While this decrease in both labor hours and the number of individuals employed is disappointing, it further demonstrates how important it is for the State Use Program to continue its efforts to increase employment opportunities for Georgians with Disabilities.

In 2019 the Council again approved the 2020 product recertification for the State Use Program at the September quarterly meeting with the continued use of the program's newly enhanced certification methodology. This improved procedure helps to strengthen the mandate within the State and aids efforts to increase sales and the labor hours which provide the opportunities which benefit those Georgians with disabilities the program serves.

As the State Use Program continues to strive for growth in such opportunities, we remain committed to leveraging our operational strategy in an effort to expand the program by finding new products and services with which to replace the ones which will inevitably reach the end of their life cycle. For that reason, it is imperative that we continue to work together to assure that this program continues to assist those individuals who benefit so much from our efforts.

On behalf of the Georgia State Use Council, I invite you to support

our efforts to put Georgians with disabilities to work. As you review this report, you will see the 'faces of state use' and the significant contributions this program is making to the lives of those involved.

We look forward to continued growth and success of the State Use Program as it serves Georgians with disabilities!

Cynthia Coleman came to BDI in June 2018, retiring after years of professional experience in the customer service/call center field working with banking corporations and Coca Cola. BDI quickly recognized her as a woman of many abilities and wanted her to be a part of the team and she was a natural fit for a position with the J&B Call Center.

Cynthia continues to give back through advocacy and education. She has educated BDI staff and her colleagues at the call center on how to react to having a Service Dog in the workplace (Hook) and in understanding the nuances of the Americans with Disabilities Act.

Cynthia says, "Having a disability in the workplace requires a special effort on both parties. BDI provided and continues to provide me with accommodations that has restored my confidence and comfortability in the work place. The contributions and the socialization of working again are priceless".

Spirit of State Use Award - Kennesaw State University

KSU was the first major university to lead by example by committing to compliance with the State Use Law's mandate specifically concerning the purchase of hand soap from GEPS. This successful implementation of GEPS soap across the KSU campus was a significant catalyst for this product line, and was critical for the program since hand soap is a product that all state facilities order. It was the success of that sizeable conversion at KSU that was a significant factor in Georgia State University making the switch as well. The precedent that those two projects set promises to help motivate the other universities and colleges across the state to commit to purchasing the soap (and other products) from GEPS that provide jobs for Georgians with disabilities and the dignity of a paycheck.

But KSU's commitment to the program does not end with hand soap. KSU purchases hand sanitizer, floor maintenance pads, first aid kits, gloves, batteries, and wiping rags. With the exception of wiping rags (which are produced at EasterSeals of East Ga. in Augusta) and the gloves (which come from the Bobby Dodd Institute in Atlanta), all of the remaining products just mentioned come from New Ventures in LaGrange and are directly responsible for the employment of many people, not the least of which is one of the above award recipients, Sanchez Thomas of New Ventures.

Kennesaw State's commitment to this program is critically important to our mission of creating jobs for Georgians with disabilities. KSU's commitment to continue purchasing those mandatory products from GEPS is the kind of cooperation that continues to provide even more employment opportunities for individuals with disabilities throughout the state of Georgia.





State Use Labor Hours of Disabled Employees FY 2018 & FY 2019 as of June 30, 2019









Total labor hours of disabled employees totaled 58,362 hours in FY19. This was a 4% decrease from the total number of hours disabled Georgians were employed in the program in FY18. There was also a 14% decrease in the actual number of workers in the program to 122.

The State Use Council designates a private nonprofit agency to administer daily operation on behalf of the Council.

This program is Georgia Enterprises for Products and Services, and its nonprofit administering agency is the Georgia Association of Training, Employment, and Supports (GATES). The State Use Council ensures that services and products are priced at a fair market value and are of the highest quality. This is a unique partnership between government and the private nonprofit sector.
